<p>The Truck Driver/Plant Operator (supporting Municipal Work) position will be based in St Helens and involves a range of duties related to the St Helens Town Litter run, maintenance and construction (including plant operation) for Roads, Storm Water, Footpaths, Kerb &amp; Channel, Waste Collection, Parks, Reserves &amp; Town Maintenance and back-up for Waste Collection.</p> <p>The Truck/Plant Operator (supporting Municipal Work) will also be required to perform labouring duties as required.</p> <p>The position will require adherence to our organisational values of “Working as a team with open and honest communication; we act with integrity whilst showing respect and being positive and proactive in our actions.”</p>
