

## **BACKGROUND**

Break O'Day Council is working to develop a Reconciliation Action Plan as a means to re-shape the thinking and attitudes of our employees and to find ways to contribute to achieving justice for Aboriginal people in lutruwita / trouwunna (Tasmania) and nationally. As part of the process of developing a Reconciliation Action Plan, our organisation is will commission an artwork by an Aboriginal and/or Torres Strait Islander artist. This will be called the RAP artwork.

This is an exciting opportunity to share your art and stories with the community. We encourage both emerging and established Aboriginal artists to apply, celebrating the rich diversity of culture and creativity within our communities.

## THE BRIEF

We have been thinking deeply about how our organisation could support Aboriginal-led businesses, Aboriginal education and/or employment opportunities, the recognition and protection of Aboriginal rights, and greater awareness and understanding of Tasmanian Aboriginal cultures and lived experiences.

Through this process of reflection – considering the past, the present, and the future, we would like to co-create with Aboriginal community partners, a piece of artwork, that tells that story.

This opportunity is open to:

- Artists living in Tasmania who identify as Aboriginal and/or Torres Strait Islander; and
- Artists who identify as members of the Tasmanian Aboriginal community, living in Tasmania.

## **ASSESSMENT**

A panel comprised of two staff members and two Councillors will assess all EOI submissions.

Neither the lowest nor any submission will necessarily be accepted.
